This Supplemental/Bid Bulletin is issued to clarify, modify and amend certain specifications/descriptions/provisions in the Invitation to Bid (ITB) and Bid Documents for the above-mentioned project. Pursuant to the Pre-Bid Conference held on 04 April 2018 at the A.B. Barretto Hall, NDC Building, Makati City, the following are additional information and modifications for the bidders.

**I. Bid Data Sheet**

1. Section 29.2 is modified as follows:

A. Certificate of Product Registration (CPR)

- Valid and current Certificate of Product Registration (CPR) issued by the Philippine Food and Drugs Administration (FDA) at the time of bidding and awarding and must be Certified True Copy by the Company Pharmacist.
- CPR must be valid for the entire period of the award; if expiring, the proof of renewal must be submitted no later than 2 months before the expiry date including the copy of updated FDA Document Tracking Log and Official Receipt, otherwise payment would be withheld or delivery not allowed.
- **For generic medicines, bidder may offer various brands for the same molecule and submit a CPR and CGMP for each brand. Provided, that the different brands being offered meet the minimum specifications and identified limitations required in the technical specification. However, if any of the brand being offered is not compliant to the specification, the entire bid will be disqualified.**

**II. Schedule of Requirements**

1. Section F.1 is modified to read as follows:

F.1 Certificate of Product Registration (CPR)

- Valid and current Certificate of Product Registration (CPR) issued by the Philippine Food and Drugs Administration (FDA) at the time of

bidding and awarding and must be Certified True Copy by the Company Pharmacist.

- CPR must be valid for the entire period of the award; if expiring, the proof of renewal must be submitted no later than 2 months before the expiry date including the copy of updated FDA Document Tracking Log and Official Receipt, otherwise payment would be withheld or delivery not allowed.
- **For generic medicines, bidder may offer various brands for the same molecule and submit a CPR and CGMP for each brand. Provided, that the different brands being offered meet the minimum specifications and identified limitations required in the technical specification. However, if any of the brand offered is not compliant to the specification, the entire bid will be disqualified.**
